  - b.) Values Trust Fund

  - d.) The balance of the Stained Glass Window project.... \$1981.25
  - e.) Marietta Food Pantry.
  - Chris Hoke made a motion to use the Community Meal Funds to pay off the Stained Glass Window project and place the remaining \$3406.94 into the Values Trust Holding Fund. Beth 2<sup>nd</sup> the motion. It passed with 5 Yeas.
- 3.) Darryl Ting has resigned as Chair of the Membership Committee. This committee plans Circle Suppers, schedules Greeters, plans New-Member classes and Orientation. Currently, Mike & Cynthia Ting, Mike & Adeline Bailey, with help from Roger & Betsy Kalter are members. As liaison to the Nominating Committee, Cory will contact George Banziger for input from the Committee. (Perhaps Charlie and Limbada would join that committee)

## New Business:

- 1. The Caring Committee is interested in donating the Stand-up Freezer (formerly used by the Community Meal) to the Harvest of Hope for surplus items. The combo freezer/refrigerator could be used to freeze meals that the Committee delivers when needed. The Board will wait for a final recommendation from the Committee. A vote will be taken next month.
