Karen Binkley presented a report from the Personnel committee addressing our Evaluation procedure.

  - 3. Karen proposed that the Personnel Committee present its recommendations to the Board at the February meeting of the Board. The Board was in agreement.

Ted presented the Treasurers' Report:

- Income \$7768 under budget in Dec.
- Expenses \$11,123 under budget in Dec.
- Therefore, our net operating expenses were \$3355 for the month
- To apply for a new PPP loan, we must prove (providing gross receipts) that we experienced a 25% cut. Ted, Linda and the finance committee will do further investigation.
- The finance committee has begun to work on the pledge drive. We need to know the pledged amount in order to prepare an accurate budget.
