



Save the Seven Principles




The Seven Principles have been a tradition in our Congregation. We often recite them as an Affirmation in worship services, and we have them on the wall in the social hall. Many members find them inspiring and some have even memorized them. Now there is a movement in the UUA to replace them with a statement of shared values illustrated with a color-keyed diagram. I find the replacement uninspiring. I am going to propose a motion in the Congregational Meeting: "FUUSM renews its support for the Seven Principles of Unitarian Universalism and asks our representatives at the UUA General Assembly to vote to retain them." I am NOT saying the UUA should NOT adopt the new statement with the multicolored image, if people like it they can have it as an additional statement. I'm just saying we should not junk the Seven Principles.

The UUA can't force us to change the FUUSM Affirmation or the FUUSM Covenant. But what the UUA seeks to do is to change its principles, which is the basis for our Affirmation, and our Affirmation is the basis for our Covenant. So, if the UUA abandons or otherwise changes its Seven Principles, it will have ramifications or at least implications on all UUA congregational Affirmations and Covenants, including ours. At least, that is my understanding.

Some Thoughts on the Proposed Revision of Article II

Opinion from Martha McGovern

I thought I'd join the conversation about the proposed revision of Article II. I am still up in the air in my thinking. I don't see that the revision would conflict with any of the principles we now hold. I do see that it emphasizes different aspects of UUism. Over my life, I've come to see that many decisions that seem to be "either-or" can be resolved with a "both-and" approach. I see the value of the proposed visual. We have become a very visually oriented culture. The image depicts how the central chalice light of LOVE becomes enacted through the guidance of key values. I also appreciate the emphasis on covenant, especially since it so clearly distinguishes Unitarian Universalism from creedal faiths.

Even in the most recent revision, I am still grappling with the words that are highlighted and their explanations. I am okay with Pluralism, Interdependence, Generosity, and Transformation as they are explained. I am uncomfortable with the word "Equity." In today's society, its commonly used meaning has narrowed to apply to the value of a business or property. I would prefer "Equality." It still carries the historical meaning of having equal rights, privileges, and status. Also,

the word "worthiness" in the current explanation falls in the same category as the word "truthiness." I would use the word "sanctity."

In fact, I would combine the sections of Equity and Justice and use the label Justice. Suggested Wording: Justice. We declare that every person is endowed with inherent sanctity and dignity and has the right to flourish. We covenant to use our time, wisdom, attention, and money to build and sustain fully accessible and inclusive communities. We will dismantle racism and all forms of systemic oppression and work for the Common Good.

I would then add a separate section of Democracy. Again, our organization and modes of operating are distinguished by our application of democratic principles and processes. I think much of the wording in the explanation of the current section of Justice could be moved to this section: We support the application of democratic principles and processes in our congregations and in society at large. We covenant to use inclusive democratic processes in governance and decision-making toward the creation of diverse, multicultural Beloved Communities.

Board Briefs by Nancy Luthy

Board members: Vic Elam, Ron Rees, Shari Ballantyne, Karen Binkley, Nancy Luthy, Robin Bozian, Darryl Ting, Rev. Kat on Sabbatical. All Board members were present at the March 11th meeting. Don Poole, Treasurer, joined on Zoom.

The Treasurer's Report was lengthy:

- We are over budget, but by year's end we will be only slightly over budget and we have adequate income. The proposed COLA (Cost of Living Adjustment) will add \$10,081.76. This has not been addressed since 2021. Robin moved: The Board approves the COLA recommendation. Karen seconded. The motion passed.
- Don will meet with the Finance Committee and prepare a proposed 2024-2025 Budget to be presented to the Board at its March 15th meeting. The proposed budget will then be sent to the Congregation to peruse before the Annual Meeting on April 28th.

Congregational Concerns: The Board shared expectations in preparation for our meeting with Mike Moore (mediator/counselor). After a lengthy discussion it became clear that many members of the Board desired a fact-finding approach instead of mediation. Robin moved: "The Board shall appoint a two-person fact-finding committee to address the grievances expressed at the dialogue sessions." Shari seconded. The motion passed: 5 yeas and 2 nays.

The Board wants the fact-finding process to move forward during Rev.Kat's sabbatical and we hope for completion soon after she officially returns at the end of June.

Have YOU Read FUUSM's Congregational Covenant? Opinion by Dawn Hewitt

Inspired by Beth Casebolt's reflection on March 17, I looked up the FUUSM Covenant. I know our Affirmation by heart, but the Covenant???

I joined FUUSM without taking a New UU course—which I now regret. There is so much I didn't know about FUUSM! My decision to join was based primarily on the Affirmation, which I hold dear (except for the word "human," which I think should be deleted). But I was unfamiliar with the FUUSM Covenant until I came across it in the FUUSM Policies & Procedures Manual that lives on the table in the RE parlor. The Covenant is Document #1.3, and was approved in October 2003. This is a document that we, as FUUSM members, implicitly agree to when we sign the book, although FUUSM "friends" are included. I think reading and agreeing to this Covenant should be an explicit requirement for signing the book.

The Covenant is also on the FUUSM.org website, but it is necessary to log in to get our policies and procedures. If you can log in to FUUSM.org, you can find it here: https://fuusm.org/index.php?page=policies-procedures

But for your convenience, here it is. Please read it:

First Unitarian Universalist Society of Marietta Congregational Covenant

We, the members and friends of the first Unitarian Universalist society of Marietta, pledge to treat one another in accordance with the principles of the Society's affirmation.

Our first obligation is to act with mutual respect in all of our church relationships.

We will use clear, direct, honest, and loving communication in reaching congregational decisions and resolving conflict within the congregation.

When reaching congregational decisions:

- We will base decisions on the principles outlined in our affirmation.
- We will base decisions on principles that support the health and well-being of
- the Society.
- We will reach decisions through the utilization of an inclusive, deliberate, and patient consensus building process before a vote is taken.
- We will respect both those with majority and with dissenting opinions.
- We will actively take part in the Society's decision making process and accept the responsibility of keeping informed of decisions made.

Once a congregational decision has been made:

- We will use at least five modes of communication to announce our decisions.
- We will respect congregational decisions once they have been reached.

When resolving conflict within the congregation:

- We will commit to develop and practice those communication skills which promote conflict resolution.
- We will commit to settle conflicts as soon as they arise.
- We will follow and lovingly remind each other to follow the Society's "Conflict Resolution Procedure".
- We will give and receive forgiveness.

THIS WE PLEDGE TO DO AS MEMBERS AND FRIENDS OF THE FIRST UNITARIAN UNIVERSALIST SOCIETY OF MARIETTA.

By the way, FUUSM's Conflict Resolution Procedure, referenced in the covenant, is document #3.5 in the book on the table in the RE parlor, and also on the FUUSM website at the link provided above.

Beth said that when a member or friend violates the covenant, we bring it to their attention, and then help them do what it takes to come back in line with our agreement. That makes so much sense for an organization that strives for inclusivity.

Five modes of communication to announce decisions? That's hard to fathom in 2003--and even today. Hmmm.... 1) in the Confluence 2) verbally as announcements during Sunday services 3) printed (and emailed) in the Order of Service 4) text messages? 5) Uh, smoke signals? the Wayside Pulpit (hahahaha)??

While our Affirmation has a prominent position on the home page of FUUSM.org, it seems to me that our Covenant should be, too. In my opinion, we need to be as familiar with our Covenant as we are with our Affirmation, and remind ourselves of that important agreement on a regular basis. Submitted by Dawn Hewitt
